We also study systems that have been retrofit with secure operating system features after an initial deployment. In all cases, the conflict between function on one hand and security on the other leads to difficult choices and the potential for unwise compromises. From this book, we hope that systems designers and implementors will learn the requirements for operating systems that effectively enforce security and will better understand how to manage the balance between function and security.
